

# Rules and Regulations

## Adrénature Parc Aventure

### **ENTRANCE TO THE PARK IMPLIES YOU AGREE TO THE PARK'S RULES AND POLICIES**

*The treetop adventure course is a recreational space allowing participants to walk along high ropes, autonomously and in a slightly acrobatic manner, on and between trees and other either natural or artificial props. It is comprised of a series of distinct, color-coded obstacle courses.*

#### Provided services include:

- Personal Protective Equipment for climbers (PPE) outfitted for climbers
- gloves and helmet on loan
- **mandatory** safety briefing – obstacle course description, handling and safety instructions
- trial test to be validated by a monitor
- supervision, advice and assistance for activities already underway

The park comprises 12 obstacle courses and 3 briefings, that is to say 200 stations total. The trails are distinguishable by name, colour and height (from 95cm to 1.5m height/ approx. 3ft11in to 4ft11in).

The Pitchoun trails are forbidden to persons measuring more than 1m20 (approx. 3ft11in) You will find these indications on sign posts at the beginning of each trail. The park is fully equipped with a Smart Safe Belay (SSB) system, guaranteeing the safety of participants.

Once the entrance fee is paid, participants are free to climb for 3 hours after the safety briefing. Climbers will either get a hand stamp or a bracelet as proof of payment. Once the 3 hours are up you will need to return the climbing gear to the outfitting deck.

#### **In case of inclement weather conditions**

**(gale, lightning storms, gusts of wind, ...) management reserves the right to temporarily or permanently evacuate the trails for your own safety.**

- Access to the trails is forbidden to the public during non-opening hours.

Opening hours are subject to change in case of inclement weather conditions.

To enter the park site (applicable to all present on the park site) you MUST:

- Have civil liability insurance
- Be vigilant and cautious: watch out for falling objects and be attentive to your footing and surrounding vegetation. (Reminder: treetop parks are found in woodland)
- Observe the safety signs. Do NOT disturb climbers by driving or parking near the stations and zip-line landings.
- No running on paths
- Preserve the environment (no plant picking or littering of any kind!)
- Keep the park site clean. Dispose of your rubbish in the recycling bins.
- **No smoking. No camp fires.**

**At all times, practice responsible and careful behaviour:**

Outdoor exercise clothing is highly recommended.

(Closed-toe shoes, trousers or bermuda-type shorts, sleeved t-shirts, NO jewelry, NO scarves, NO loose hair).

**Do not wear any objects risky of falling**

**Management reserves the right to refuse entrance to the park and its grounds to any individual who does not comply with the rules and regulations here stated.**

**To climb you must:**

- Be in good physical and mental health. No one under the influence of alcohol or other mind-altering substance will be admitted
- Weigh under 110 kilos (approx. 17 stone (UK) / 242 lbs. (US) and/or have a waist size under 110 cm. (approx. 43 inches) (We reserve the right to both weigh and measure you).
- Pay the entrance fee
- Comply with size, weight and height restrictions for each trail
- Listen to the safety briefing and **pass the trial test which must be approved by a monitor. This is required to practice any activity (even our regular customers)**

- Underage climbers under the age of 14 must be accompanied by an adult who must remain present during the activity.
- Children under the age of 6 **must be chaperoned** by an accompanying adult for the duration of the entire activity. The child must comply with the safety instructions and proper use of the climbing gear.
- Participants must respect the safety and security instructions provided.
- Have read and understood **the posted information** pertaining to:
  - safety instructions and climbing gear.
  - the different markings and signs explained during the safety briefing
- Observe and follow the instructions at every station/game, namely getting from one station to the next, as well as the specific safety instructions (red rope with snap clip on the vertical games)
- Respect the number of authorized persons per station and per platform (1 person/station or game and 1 person/platform)
- The use of mobile phones is prohibited during the activity.

**YOU ARE AUTONOMOUS AND ARE RESPONSIBLE FOR YOUR OWN SAFETY**

- Each participant is equipped with safety equipment provided by us and double-checked before a climbing session. All the climbing gear will be inspected after usage. Personal climbing gear is not allowed.
- After the safety briefing, individuals feeling either physically or psychologically unfit to correctly and independently partake in the activity should refrain from practicing it (no reimbursement)
- The same applies to anyone who does not pass the trial test.
- Permanent, continuous self-protection is obligatory (life lines, safety buckles and other indicated elements)
- It is strictly forbidden to interrupt and/or abandon a trail without the assistance and authorization of a monitor.

In the event of a problem, please inform a monitor by any means necessary. You can recognise the monitors by their black t-shirts with the Adrénature logo.

**It is prohibited:**

- to use a trail or obstacle course without meeting size, height and weight restrictions
- to interrupt and/or abandon a trail without the assistance and authorization of a monitor
- to remove the harness while on the course
- to come to rescue a participant on an obstacle course, to use the trails, ladders and games without a safety harness
- to leave the parc grounds with the harness, helmet and gloves
- to smoke while wearing your equipment (harness, helmet and gloves)
- to remove your equipment elsewhere than the outfitting deck
- to swap your harness with someone else or to return solely your harness upon check-out time

**Access to Quick Jump:**

You must have paid the special entrance fee to this activity. You will get a bracelet to wear as proof of payment.

You must be accompanied by a monitor to get to the course.

No reimbursement if you choose not to jump

No jumps between 12:30 and 1:30 p.m.

**Access to the Fishing Net:**

The Fishing Net is located near the Pitchoun trail. It is reserved for children measuring under 1M20 (approx. 3ft11in). They must wear either the yellow or pink bracelet handed to them at the time of payment.

Children need to be accompanied by at least one adult. Their climbing gear must be removed before going on the net so as not to hurt themselves with the pulley and the safety hook. Shoes must be worn. Access to the net is free for children under the age of two.

**Adrénature Parc Aventure is covered by professional liability insurance:**

Adrénature cannot be held liable for damage, loss or theft of personal objects (clothing apparel, personal objects, mobile phones, glasses, etc.) of participants, chaperones or visitors. Adrénature is not responsible for any theft which may occur in the car park or the grounds.

Adrénature Parc Aventure declines all responsibility in case of an accident due to non-compliance to safety rules and/or to the the park's rules and regulations. In case of loss or damage to equipment, props, material and climbing gear Adrénature Parc Aventure reserves the right to claim indemnities from the participant(s).

Adrénature Parc Aventure reserves the right to deny admission to any individual who:

- does not respect instructions
- displays unsafe behaviour to him/herself or others
- is disrespectful towards staff, material, clients and the park grounds

Management reserves the right to make and apply any decision deemed necessary.
